### SCHEDULE OF AMENDMENT

### TO THE

# DECLARATION OF RESTRICTIONS, LIMITATIONS, CONDITIONS AND AGREEMENTS

OF

### SUNSET REEF

The following is added as Section 4 to Article VI of the Declaration of Restrictions, Limitations, Conditions and Agreements:

# SECTION 4.

- (a) Association Responsibility. The Association shall have the power and authority to Association shall have the power and authority to maintain and replace, at the Association's expense, all exterior surfaces of the units, including normal wear and tear of stucco, paint, balcony walls, railings and ceilings, and roof areas. The Association shall also maintain normal wear and tear of the hinged entrance doors at the front and rear of each unit.
- Responsibility. The Owner shall Owner maintain in good condition and repair, and replace at his own expense, notwithstanding insurance recoveries, all portions of the unit except those portions to be maintained, repaired or replaced by the Association. This shall include, but is not limited to skylights all screens windows and limited to, skylights, all screens, windows and frames, sliding glass doors and frames, french doors, overhead garage doors and all floor surfaces. The Owner will also be responsible for any pest control in his unit.

Article VIII, Section 13, of the Declaration of Restrictions, Limitations, Conditions and Agreements is amended to read as follows:

SECTION 13. Leases. The tenant will be bound by the rules and regulations of the Association and it will be the responsibility of the Owner to provide the tenant with a copy of these restrictions and all other rules and regulations promulgated by the Association. The Owner shall be responsible for the conduct and actions of his tenant. No lease or rental will be less than thirty (30) consecutive days in length.
